

Flower Placement and Decoration of Graves

The Corporation reserves the right to regulate the method of decorating lots so that a uniform beauty may be maintained. The Corporation reserves the right to prevent the removal of any flowers, floral designs, trees, shrubs or plants, or herbage of any kind, unless the Superintendent gives his consent.

All work and planting of any kind on all lots and graves by the Lot Owners is strictly prohibited. The Lot Owners shall not perform planting of any kind on any lots and graves, and doing so is strictly prohibited.

No boxes, cans, bottles, jars, shells, toys, discarded glassware, sprinkling cans, receptacles, or similar articles will be permitted on any grave, lot or tree.

Cut flowers in approved containers may be used at any time.

No flower receptacles may be placed on any Plot unless approved by the Corporation, and then they shall be of approved size, material and design, set wholly beneath the level of the lawn. The Corporation shall not be liable for floral pieces, baskets or frames in which or to which such floral pieces are attached. The Corporation shall not be responsible for damage by the elements, thieves, vandals, or by other causes beyond its control.

Artificial flowers and fresh flowers will be left in vases on bronze markers until they are withered or become soiled, at which time they will be removed and vases will be inverted into the marker.

The use of artificial flowers between March 1 and November 1 of each year is strictly prohibited unless such artificial flowers are in the vase contained within a bronze memorial. Artificial wreaths or arrangements will be permitted during the period of time between November 1 and March 1.

The use of glass permaviewers or any type of constructed cases will not be allowed any time of the year.

Potted plants can be used on special occasions such as *Easter, Mother's Day, Father's Day, Memorial Day and Veteran's Day*; however, such plants shall be removed within seven days from the placement on the lots and graves by the Lot Owners. If not so removed by the Lot Owners, employees of the Cemetery shall have the right to remove and dispose of all objects at any time after said seven day period.

The digging of holes in the turf for the purpose of setting vases or plants is prohibited.

There will be a charge for flower placement by Cemetery personnel.

The Corporation shall have the authority to remove all floral designs, flowers, weeds, shrubs, plants, or herbage of any kind, from the Cemetery as soon as, in the judgment of the Superintendent, they become unsightly, dangerous, detrimental, or diseased, or when they do not conform to the standards maintained. The Corporation shall not be liable for floral pieces, baskets, or frames in which or to which such floral pieces are attached, beyond the acceptance of such floral pieces for funeral services held in the Cemetery. The Corporation shall not be responsible for frozen plants, or herbage or any kind, or for planting damaged by the elements, thieves, vandals, or by other causes beyond its control.
